- 1 **noted** that on 26 June 2019, SWC agreed to policy objectives and parameters to guide the free and healthy school lunch prototype (the prototype) [SWC 19-MIN-0077];
- 2 **noted** the update from the Minister of Education (the Minister) on the prototype;
- 3 **agreed** to extend the free and healthy school lunch programme to Year 9-15 students who attend composite schools selected for participation in the prototype;
- 4 **agreed** that the Minister will make decisions on a case-by-case basis on the provision of funding for free and healthy lunches to Year 9-15 students in Year 7-13 secondary schools within the prototype.

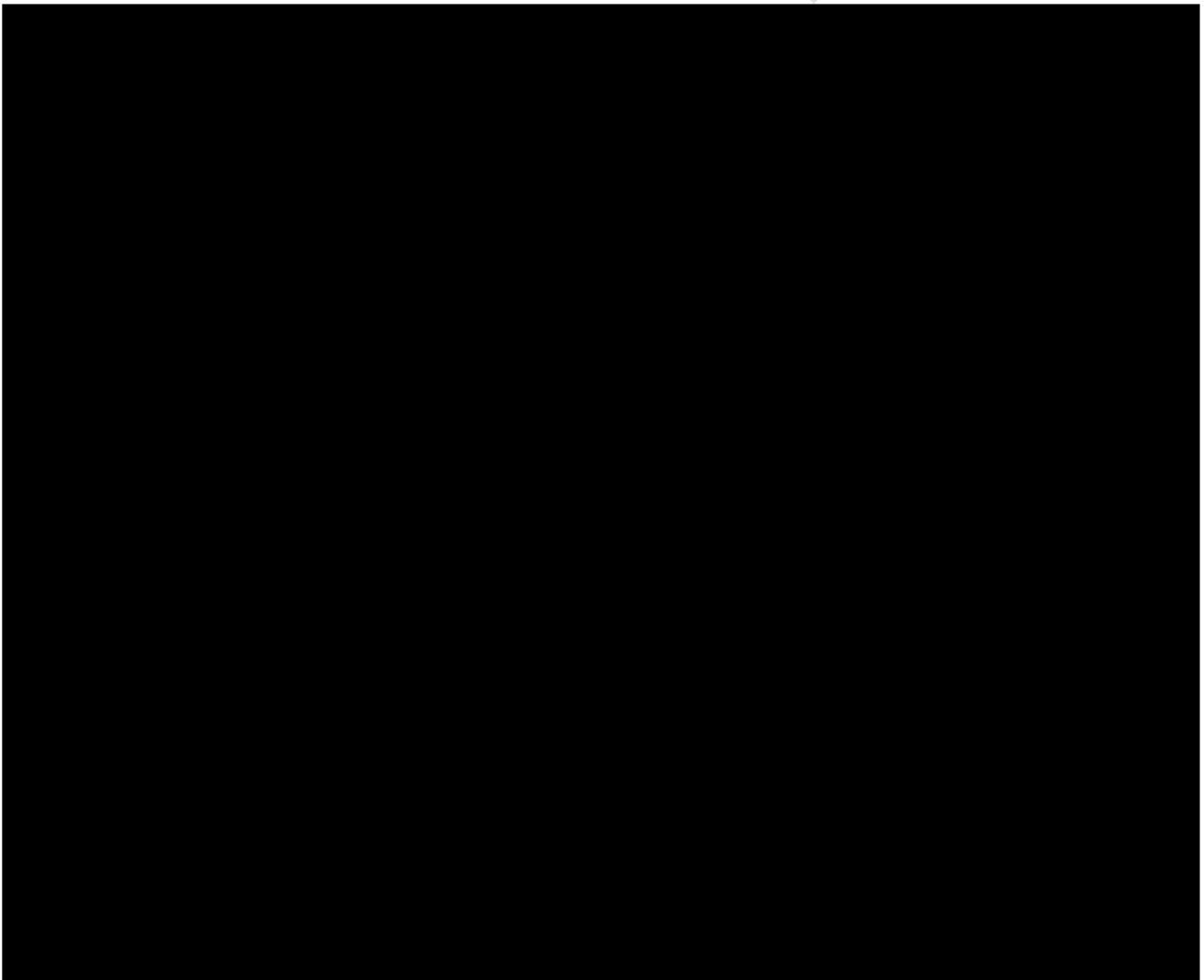
