Purpose of Report

The attached draft Cabinet paper and Appendix seek Cabinet approval to finalise a Statement of National Education and Learning Priorities (NELP) and Tertiary Education Strategy (TES). Background

1. On 12 June, we provided you with a NELP and TES at a glance which set out the priorities that form the NELP and the TES. In your agencies meeting on Monday 15 June, you indicated that you were happy with the plan on a page, but asked for some further work, including additional information to accompany it.
2. In particular, you asked us to bring out what the Ministry of Education and other government education agencies will do to support the sector to realise the ambitions of the NELP and TES, and to show what places of learning are being asked to do.
3. You also asked that that the level of integration and alignment between the NELP and TES and the rest of the Education Work Programme be shown more clearly, and for more information to be included in the Cabinet paper about how places of learning will be supported through the implementation of the NELP and TES, and able to self-assess their progress against the priorities.

Changes made

Draft Cabinet paper

4. We have further amended the implementation section to bring out more clearly what the roles of Government and places of learning will be in implementing the TES, what support the Government agencies will provide to places of learning, particularly in the schooling sector. We have included further additional detail about how places of learning will be able to assess their progress against the priorities.
5. We will complete the communications section before going to Cabinet. Once we know likely dates for publishing the NELP and TES, we will be able to finalise the details of a communications approach.

Appendix A – NELP and TES document

6. The Cabinet paper seeks approval to publish the NELP and TES attached at Appendix A. This document illustrates the connections with the broader education work programme, and the alignment between the Government's five objectives for education and the subsequent NELP and TES priorities.
7. For each priority, the document sets out why the priority is important, and what good looks like. Including some of the rationale and outcomes will help places of learning to understand what is being asked of them, and why. The Tertiary Education Commission (TEC) has also indicated that including outcomes helps them to give traction to the TES priorities through the investment plan process, which asks Tertiary Education Organisations to show how they will respond to the TES priorities.
8. The NELP and TES document includes a separate implementation and action section for each part of the education system – licensed early learning services, schools and kura, and tertiary education organisations. Each of these sets out, for the relevant part of the sector, 3-4 actions per priority that they should focus on, and the actions that Government will take to support the sector to realise each priority.

Next steps / Cabinet timeline

9. At the advice of your office, we have commenced agency consultation. We propose to discuss this paper with you at your agencies meeting on Monday 20 July, and recommend that Ministerial consultation take place from 21 July to 27 July, if you

agree to this draft. This timeframe recognises the minimum of five days required for ministerial consultation.

10. We had previously planned to lodge this paper on 23 July however there isn't sufficient time to complete consultation within that timeframe.
11. We therefore recommend finalising a draft of the Cabinet paper and attached NELP and TES for lodging on 30 July, for consideration at SWC on 5 August and Cabinet on 10 August. We note that this is the final opportunity to seek Cabinet approval prior to the House rising.
